ORDER

BEFORE MRS JUSTICE HILL DBE

UPON reading the Claimant's application dated 12 October 2023 and supporting witness evidence

AND UPON the Court being satisfied that a hearing of the application would not be appropriate such that under CPR 23.8(1)(c) the application could be determined on the papers

IT IS ORDERED THAT:

AMENDMENT OF THE CLAIM FORM AND PARTICULARS OF CLAIM

1. The Claimant has permission to amend their Claim Form and Particulars of Claim in the draft form submitted with the application.
2. The perfected amended versions of the documents shall show the amendments in red underlined / struck through (not tracked changed) text, in accordance with PD 17, para. 2.4.
3. The said versions shall be verified by a Statement of Truth and filed and served within 7 days of the service of this order.

DEEMED SERVICE OF ORDER DATED 23 MAY 2023

4. It is ordered that the steps already taken by the Claimant to effect service at not less than half of the Shell Petrol Stations as set out in the Fourth Witness Statement of Alison Judith Oldfield amount to good service and that the Order of Mrs Justice Hill dated 23 May 2023 is deemed to have been served on 24 July 2023.

Pursuant to CPR 6.15(4)(b) and 6.27, the amended Claim Form and amended Particulars of Claim shall be deemed to be served on the latest date on which all the methods of service referred to in paragraph 5 have been completed in respect of this order, such date to be verified by the completion of a certificate of service.
8. The Court will provide sealed copies of this Order and Amended Claim Form to the Claimant's solicitors for service (whose details are below).

FURTHER PROVISIONS

9. As this order was made without a hearing and on short notice to the Defendants, either party may apply to have the order set aside, varied or stayed within 7 days of service of this order.
